1. NAME:

4. AMENDMENT:


The memorandum of association & rules & regulation registered vide registration no. ROS-617 YEAR 2006-2007 with Distt. Registrar of Firms Societies, Haryana are amended due to the resignation of Sh. Satpal S/o Sh. Jagat Singh and introduction of two new members. (i) Sh. Rajinder Golen S/o Sh. Randhir Singh Golen, Vice-President (ii) Smt. Sushila Golen W/o Sh. Rajinder Golen, Member.

- To promote and develop different Indian languages and literature.



To own, purchase, construct, setup erect, take on hire all such buildings and other property moveable and immovable whichever is considered necessary and useful for any kind of the institution to be established by the society.

- f) To do any other act or dealing which the Managing Committee decides for the benefit of the society in general.
- g) To do and cause to be done all such lawful things as are in accordance with the spirit of the principles and objects of the society which are conducive or incidental for the attainment and pursuit of the time and objectives of the society.
- h) All the income of the society shall be utilized for the promotion of education and achievement of the other object of the society.
- i) To provide medical and any other help to the needy students. The Institution can be opened in any state under any name as per resolution passed by the societies.
- j) To help all deserving students in distress regardless of caste, colour and creed.
- k) To give, provide and/or render help or assistance to and/or implement any scheme for providing livelihood & upliftment of the poor students.
- l) To receive donation from public and commercial institution for the promotion of the objects of the society.
- m) To run adult literacy projects to literate the illiterate.
- n) To disseminate spiritual knowledge by publication in any form dealing with the ancient, oriental and accidental philosophy and religion by arranging spiritual discourse, conference, yoga training centre and other similar institution.
- o) To do all type of charitable work as the Society may consider from time to time for the promotion of education.
- p) The said society shall invest the money, its income as prescribed under the income tax act and other statutory laws.

RULES & REGULATIONS
MAHAVIR SHIKSHA SAMIT

1. The membership of the Society shall be open to founder family members on the approval of Governing body subject to maximum of 8 members to the society.
2. **MEMBERSHIP & FEES**
Those who give Rs. 11000/- to the Society, they will be its lifelong members. Those who pay Rs. 1100/- they will be members till the next election of the Managing Committee. Financial year will be reckoned from 1st April to 31st March. The age of the member should be at least 21 years. He should be mentally & physically fit and loyal to the Society. A member who is an undischarged insolvent or who has been convicted of any offence in connection with the formation, management or of the affairs of the society or of any offence involving moral turpitude or tarnished image shall not be entitled to be a member or office bearer of the Managing Committee.
3. The income and the property of the Society shall be applied solely towards the promotion of the objects of the Society as set forth in the memorandum of the MAHAVIR SHIKSHA SAMITI and no portion thereof shall be paid or transferred directly, to the members of the society.
4. No member of the Governing Body of the Society has been appointed to any salaried office of the society or any office of the Society paid by Fees, that no remuneration shall be given by the Society to any member of such expenses except interest on money or rent for premises of the society or any honorarium as according to his/her qualification.
5. MAHAVIR SHIKSHA SAMITI by its constitution will apply its profit if any or other income in promoting its objects.



6. **TERMINATION OF MEMBERSHIP:**

- The membership of the General Body of a member shall be terminated / relinquished under the following conditions:
 - i. On death or permanent insanity.
 - ii. On tendering resignation provided it is accepted by the managing committee.
 - iii. On becoming defaulter as mentioned in the clause 2.
 - iv. On expulsion by majority of votes in the meeting of the General Body.
 - v. On absences of members in a meeting called by the Governing Body continuously three times.

7. **GENERAL BODY:**

- . All its powers shall vest in the General Body.

Meeting of the General Body:

- i. The meeting shall be held at least once in a year or at any time whenever an urgent business is to be discussed.
 - ii. The president of the Managing Committee on his own accord or on the written request of at least 2/3 members of the General Body shall have the powers to convene the meeting of the General Body.
 - iii. Generally the meeting of the General Body may be with 15 days notice along with Agenda. However, an emergency meeting may be called on short notice of 24 hours also.
 - iv. *The term of governing body shall be three years from the date of approval of its election. at least 45 days prior to the holding of GM for conduct of the elections.*
8. All Matters will be decided by majority of votes and in case of votes becoming equal, the President shall exercise a casting vote.
9. The quorum for conduct of the meeting will be presence of two third (2/3) in the meeting. In case half of the quorum is not there, the house would wait for half an hour or suspend the meeting for half an hour to wait for any member to turn up after which the meeting will be conducted accordingly.

10. All the proceedings of the meeting of the General Body shall be recorded and got signed from the members of the Body by the president of the meeting.
11. The General Body shall:
- Elect form amongst the member of a Managing Committee.
 - Having powers to suspend or dismiss any member of the committee whenever, the member losses confidence to the General Body.
How ever the suspension/dismissal of the President shall follow after an enquiry into the charges by a Committee consisting of at least member from the General Body.
The report of comments of the enquiry committee shall be considered by the Managing Committee.
 - Consider the Annual report of the working of the institution, the annual budget and balance sheet prepared by the Managing Committee. It shall issue instructions to the Managing Committee for the smooth and efficient working.


12. **MANAGING COMMITTEE:**


- Managing committee shall consist of Four elected member including the President, Vice-President, Secretary and Treasurer of the committee.
- On the occurrence of any vacancy amongst the members of the society due to death voluntary retirement or due to clause no. 6, the vacancy will be filled from his/her legal heirs or by his/her will but, if there is no legal heir or the legal heir is unfit to become founder member of the society then the Managing is at Liberty to co-opt any person from the member of the families due to which vacancy has created in his or her place. But in case of dispute among legal heirs for the founder member then the member of the governing body can make any legal heir as member against the vacancy of the deceased by 2/3 majority.
- The president shall always be out of founder members or their heirs/ successors of the founder members who will be elected by the members of the Managing Committee of the society by majority of members present in the meeting call for such purpose.





- c. The managing committee will have four members form founder members or their legal heirs or successors.
- d. All matters will be decided by the majority votes and in case of votes being equal, the President of the committee will cast a casting vote.
- e. The president at his own accord or at his requisition of majority of members of the Managing Committee shall convene the meeting of the Managing Committee.
- f. The meeting of the Managing Committee shall have full powers of appoint, suspend or dismiss any employee of any of the institution to be set up by the Society.
- g. The meeting of the managing committee will be held whenever considered necessary at seven days/notice or earlier for convening the meeting in ordinary course.
- h. To take over, or absorb any other society or association or institution whose objects are similar to the objects of society.
- i. The managing committee with the help of other officials including the Manager/Treasurer shall maintain up to dates accounts of all affairs and property of the Society of the institution being set up and shall be responsible to submit the annual budget, balance sheet, income and expenditure and annual report for submitting to the General Body.
- j. The Managing Committee may appoint a person(s) of the Institution set up by the Society and fix his powers/duties pay/honorarium and other benefits.
The Managing Committee of the Society shall have powers, subject to the Society to do all such acts, deeds and things as are necessary or for the Management of affairs of the Society or which may be conducive to the attainment of the objects or any of them.
- k. Decides on the establishment of branches or closure of the existing ones in the interest of the society.





VICE-PRESIDENT SH. RAJINDER GOLEN




The Secretary shall perform all the duties and works of the Society and to act in a way that proper and correct functioning of the Society.


